- V. 1. It was unanimously agreed and resolved that Trust be constituted to the smooth functioning of the school.
- 2. Trustees decided and agreed that the school building was to be hired on rent/lease and the school building or field or other structures would be used for education and for development of skill and efficiency.
- VI. Trust is in non proprietary in character and Trustees are not in family relation.
- VII. It was resolved that sir Anil Prakash would function as chairman and sri Ajaya Kumar Singh would function as vice chairman and they are life long permanent members.
- VIII. The posts of chairman, vice chairman and members are honorary and in the absence of chairman, vice chairman can take decisions.
- IX. Board of Trustee - The trust is administered by a board consisting of a minimum number of Five and maximum number of Ten in which the first two members as laid down in para Two and Seven of this deed namely Shri Anil

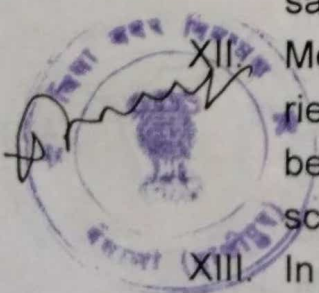

Prakash, Sri Ajaya Kumar Singh would be treated as permanent trustee and the remaining trustee would be nominated trustee selected from amongst persons of integrity without any distinction of the caste, creed, religion or sex.

- X. In Future nominated trustees may be made permanent other member would be nominated or selected.
- XI. Sri Anil Prakash as chairman and Sri Ajay Kumar Singh as vice chairman of the trust volunteered to provide their valuable experience and guidance. Each of them donated a sum of Rs. 25,501 (Rs. Twenty Five Thousand Five Hundred One only) Total Rs. 51,002 (Rs. Fifty One Thousand Two only) as a corpus money for the trust.

XII. Members of the board of trustee decided to arrange experienced and competent principal, teachers and staff members i.e. teaching as well as non teaching staffs for the school and for educational purposes.

XIII. In order to achieve and fulfill the above said aim and objec-

tive it was resolved in the proceeding that a school named St. Michael's School at Lalganj was to be opened in an atmosphere free from hustle and bustle of the city.

XIV. It has been resolved in the general assembly of the proceeding of the trust that the school functions in accordance and as per consitution mentioned values.

XV. In case of death of trustee or resignation or vacancy caused by any other reasons of any of the member it would be responsibility of the remaining members to nominate or select another member to fill up the vacancy. In case of any differences the nomination would be decided by the mojority of votes. To ascertain the mojority help from nominated members may also be taken.

XVI. Before assuming office in the Trust a new trustee would give his/her consent in writing to set on the trust & a trustee will cease to be a member of trust in case of death or in becoming insolvent.

XVII. Meeting of the Trust-Regular meetings of the trust would

- be held at least six monthly or more frequently if required in the school campus or a place predecided by the chair man.
- XVIII. Meeting notice will be sent to every trustee. Each one will to cast one vote and the decision will be taken by mojority. However information to all trustees should be ensured as far as possible.
- XIX. The trust will accept donation which will be used for the further development of the trust as well as for the school especially in educational purposes.
- XX. Trustees request chairman & vice chairman to take necessary steps on behalf of trust for further expansion of this trust which may help in promoting quality education in area or in weaker areas or for opening a new school.
- XXI. The trustees reserve the right to frame any rules as addition, omission or amendment on any time for the betterment of the trust which will depend upon the need and situation.

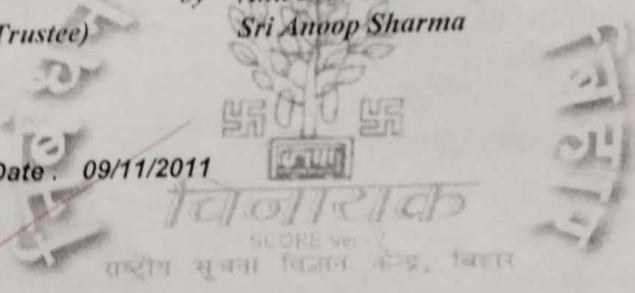
